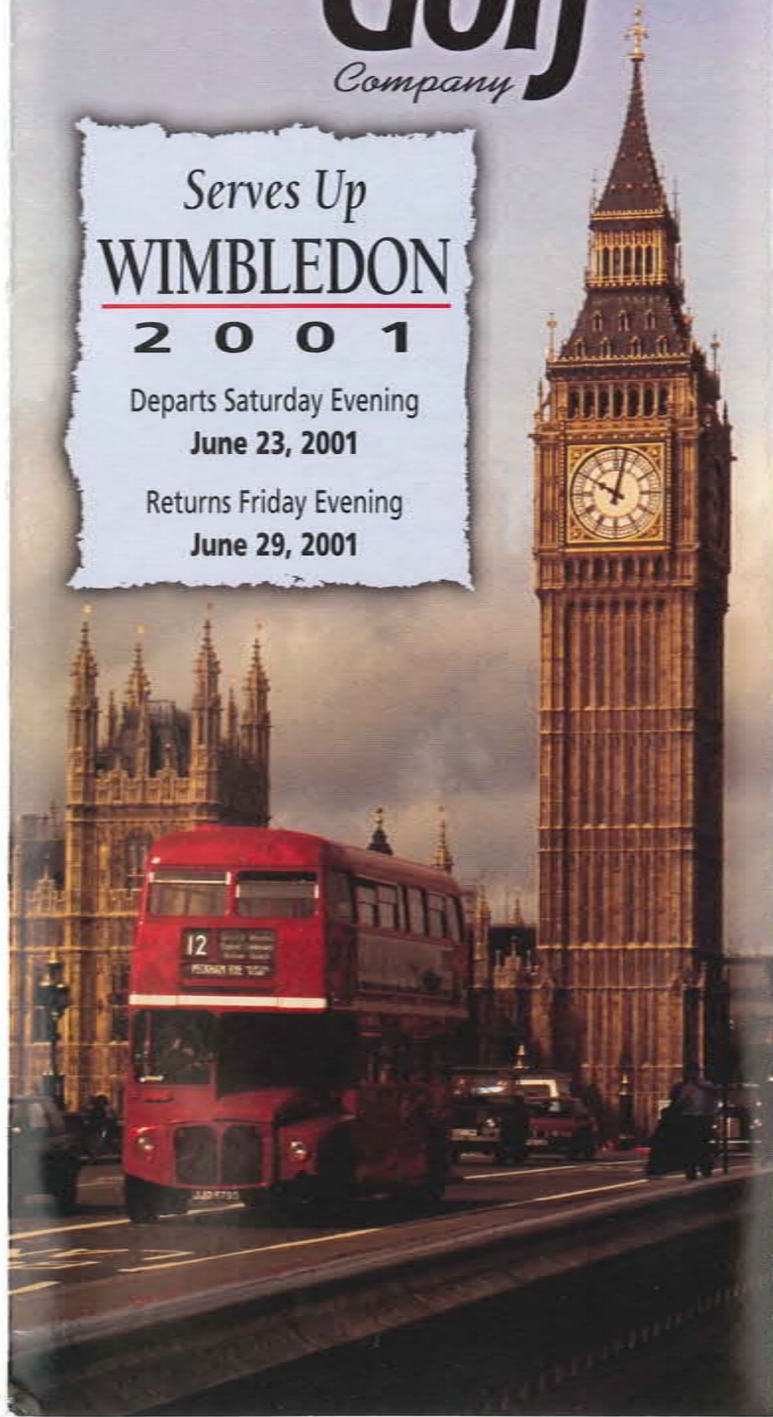

*This tour affords you the opportunity to view the first two days of the Wimbledon 2001 matches from premier seats.*

**June 23:** Depart from Detroit's Metro Airport on a direct British Airways flight (7-8 hours in duration) to London's Heathrow Airport. London is 6 hours ahead of Eastern Daylight Time.

## Tour Specifics

**ACCOMMODATIONS:** Our hotel is a superior 4-star, first class London hotel in traditional British style. All rooms were refurbished in 1999. Three restaurants are available on-site along with fitness facilities. The hotel is centrally-located and within easy walking distance of the major London sites.

**TRIP INFORMATION PACKAGE:** After we have received your application and deposit, we will send you a letter of acceptance confirming your reservation and a trip release form. When we receive your trip balance, we will send you a packet of information containing: various travel and packing tips; a comprehensive guide to London sightseeing; and an order form with optional sightseeing and nightlife excursions. Airport taxes (excluded from your trip price, and currently about \$90) will be fixed approximately 45 days prior to departure, and you will be invoiced for the final amount at that time.

**WEATHER** There's no way that we can predict the weather and the dates of your Wimbledon tickets are fixed (you won't be able to attend Wednesday's matches should Tuesday's become washed out). While we are unable to transfer tickets to any future matches, we will help you plan optional sightseeing excursions, should your days' matches be postponed due to the weather.

## Terms and Regulations

**1. REGISTRATION:** CBT must receive a complete application, signed by each participant, and accompanied by a \$500 DEPOSIT which is applied to the trip cost. This DEPOSIT is completely refundable through August 31, 2000. Any deposit made on or after September 1, 2000 is non-refundable unless the trip is full.

**2. SECOND PAYMENTS:** The applicant, upon receipt of a letter of acceptance from CBT, will send a final payment and signed trip release form, which is due March 1, 2001. NOTE: CBT reserves the right to cancel an application for which payments have not been received as per the above schedules (with appropriate penalties).

**3. CANCELLATION OF APPLICATION AND/OR REFUNDS:** Cancellation penalties for cancelled applications are listed below. For all cancellations, CBT will retain (in addition to non-refundable DEPOSITS detailed above):

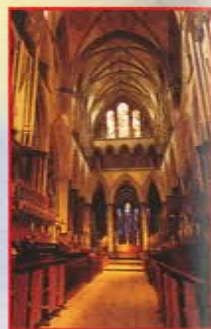
- \$1000 if cancellation is made between and including Sept. 1, 2000-Feb. 28, 2001.
- 100% of all moneys received if cancellation is made on or after March 1, 2001.

**4. TRIP COST:** The total trip cost includes all evening accommodations and meals as specified in this brochure, transportation to and from the beginning and ending cities on each tour, sightseeing costs as indicated above, and leadership costs.

**5. INSURANCE:** CBT recommends, upon receiving confirmation of your trip acceptance, that you purchase short-term traveler's insurance that covers baggage, accident/life, trip interruption, and trip cancellation insurance. Trip interruption insurance reimburses you for certain non-refundable travel costs should you have to return home because of certain personal reasons or illness. Trip cancellation insurance reimburses you for certain non-refundable travel costs should you need to cancel your application because of illness or accident. CBT strongly recommends that you purchase insurance for your material belongings to protect you from theft, loss, vandalism, and any other unanticipated losses that occur during your tour.

**6. TERMINATION OF TRIPS:** CBT Tours (CBT) and The Tennis and Golf Company (TGC) reserve the right to shorten or terminate a trip already in progress if CBT and TGC deem it necessary for the safety or well-being of the group. In the event that a trip is terminated, a refund will be issued to each participant based on his/her share of all unused funds. Refunds, if any, will be made depending on whether or not refunds can be obtained for transportation and prepaid accommodations payments. CBT and TGC also reserves the right to alter the above itinerary with similar lodging and meal plans.

**7. LIABILITY:** A signed trip application denotes that the signer understands and agrees that CBT and TGC act as agents only and accept no responsibility for loss, damage, or injury resulting from delay or any kind of negligence of any transportation company or any other agency in the service of CBT and



TGC or from any outside party. NEITHER CBT NOR TGC CAN BE RESPONSIBLE FOR LOST, DAMAGED, OR STOLEN ITEMS, WHICH IS WHY IT STRONGLY RECOMMENDS THE PURCHASE OF INSURANCE. The signer further agrees to assume responsibility for any and all debts incurred during the trip by himself/herself.

**8. CONDUCT:** If any participant is found to be responsible for any damages while on the tour, he or she will be required to immediately pay for such damages. CBT and TGC reserve the right to expel a participant from a trip if their behavior is considered by the leader or other authorized CBT or TGC employee to be detrimental to the group or to the good name of CBT or TGC. No refunds will be given to a participant who is expelled from a trip.

**9. GENERAL AND TRIP MODIFICATIONS:** A signed application denotes that the signer understands and agrees that CBT and TGC reserve the right at any time to retract and change these Terms and Regulations and other conditions stated within this brochure and other literature printed or published by CBT or TGC, and to make any other reasonable terms and regulations and conditions that it deems necessary for the safety and well-being of its participants. CBT and TGC also reserve the right to modify the existing itinerary with reasonable substitutions.

**10. EXCEPTIONS TO POLICIES:** Exceptions or changes to the above Terms and Regulations and all other policies can only be made by the Director and are valid only when placed in writing by a Director.
